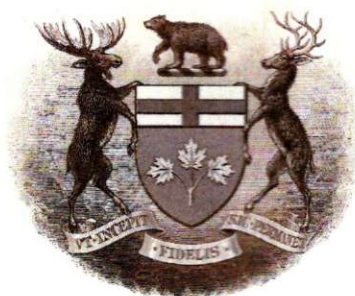
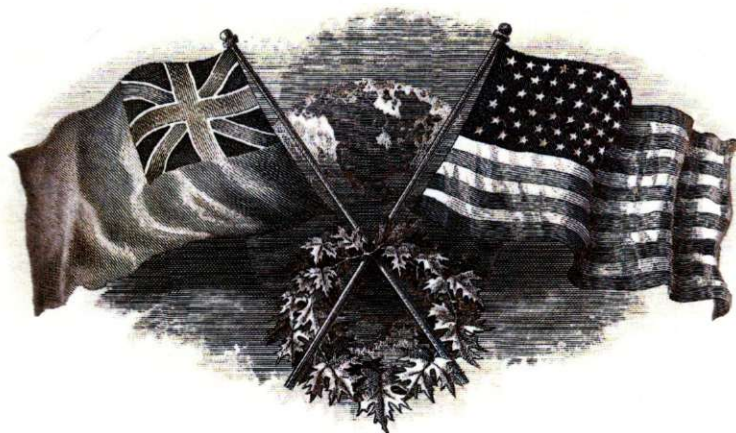

1. Only souvenir cards, intaglio-printed material, or related items are acceptable for consignment. Interested sellers should **contact the auctioneer with any questions BEFORE sending any material.** The fastest contact is by e-mail;

2. Consignors are responsible for adequately describing their lots, including S.C.C.S. numbers and their minimum bids. Lots must be of a minimum \$1 value.

3. Consignors will pay the postage to ship their lots and postage/insurance for return of unsold material. There is NO consignment fee, however, the S.C.C.S. will retain 10% of the selling price as a commission fee. Care shall be taken to protect any material submitted, but the auctioneer and the S.C.C.S. assumes NO liability and the consignor(s) should verify and/or provide their own insurance coverage.

4. **Lots will be sold to the highest bidder.** In the case of tie bids, the first bid received shall be awarded the lot. Bids below the "minimum" listed are NOT accepted. Bid in \$1.00 increments only, i.e., NOT "cents." There is NO "buyer's premium".

5. Successful bidders will pay the postage, insurance and packaging for their lots. NO lots will be shipped until the notice for same is paid in full. Payment is expected within ten (10) days of notice. Late payment may result in exclusion from future bidding. Checks should be made out to the auctioneer NOT the S.C.C.S.

6. Bids and/or questions may be e-mailed—the quickest way—regular mail, or carrier.

7. Returns are acceptable within ten days of receipt of shipment. Please specify the reason for the return (damage, mis-attribution, etc.) Mistakes on the bidder's part are NOT sufficient reason for return.

8. **Bidders are asked to total the amount of their bids to ensure accuracy of your submitting them and in my entering them.** Lots marked • are illustrated. Look carefully, bid wisely and early!

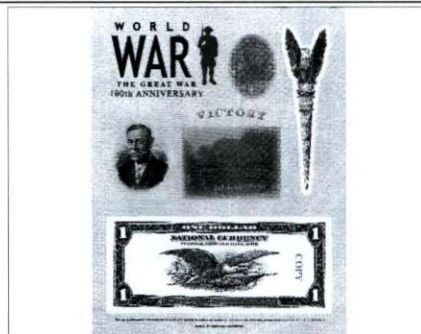

World War I: 100th Anniversary 2018 Intaglio Print Collection

World War I: The Great War 100th Anniversary

The Treasury Department issued currency, stamps, and Liberty Loan Bonds produced by the Bureau of Engraving and Printing (BEP) to assist with financing the Great War. This collection highlights inspiring allegorical and historical figures, as well as engraved American iconography featured on currency, stamps, bonds, and posters issued during the war.

The World War I 100th Anniversary commemorative collection consists of three intaglio prints — Entry, Homefront, and Victory.

Victory

On November 11, 1918, a truce between the Allied powers and Germany ended the fighting during World War I. The Treaty of Versailles was signed on June 28, 1919, officially ending the Great War.

During World War I and immediately following the war, the BEP printed more than 130 million individual war bonds. By the end of the war, half of all American families had purchased a Liberty Loan, raising more than \$21 billion for the war effort. The talent and dedication exhibited by BEP employees allowed the Bureau to meet all Liberty Loan orders, printing a record number of bonds and providing substantial financial support for the war effort.

Top Right – Eagle perched on a mace

Engraved by Charles M. Chalmers. Coupons from the Victory Loan featured the same engraved eagle with its wings outstretched in a victorious V.

Top Right – General John J. Pershing on horseback leading World War I veterans during a parade in New York.

Center – Parade for the soldiers of the U.S. Army 27th Division in New York City after World War I, passing the New York Public Library.

Center Left – Portrait of Woodrow Wilson

Engraved by G. F. C. Smillie. Woodrow Wilson served as the 28th United States President during the war and was involved with negotiating terms of the Treaty of Versailles.

Bottom – \$1 Federal Reserve Bank Note, Series 1918, back

Engraved by Marcus W. Baldwin, Joachim C. Benzing, Howard I. Earle, Edward M. Hall, and Edward E. Myers. In 1918, Federal Reserve Bank Notes were issued to assist with the financing of the war abroad while also insuring a stable market at home.

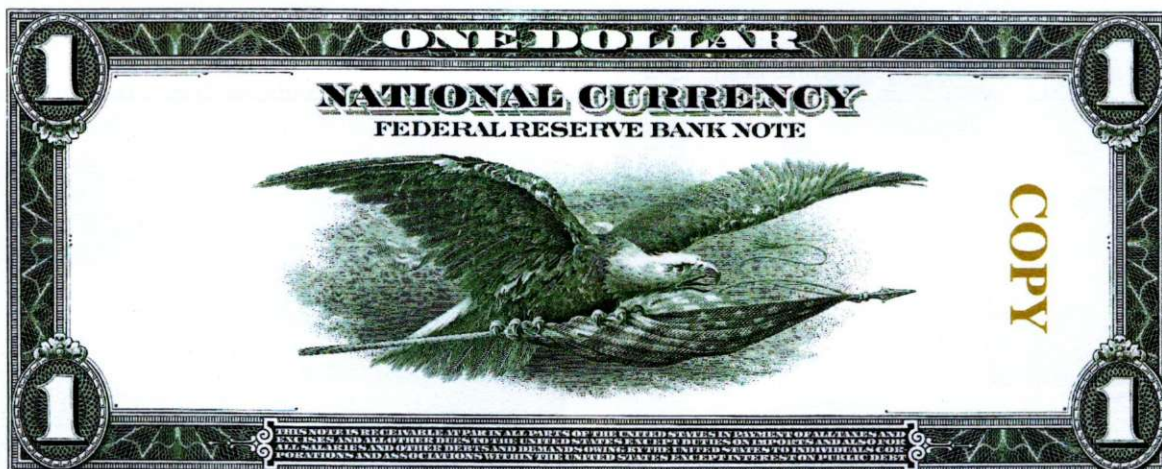
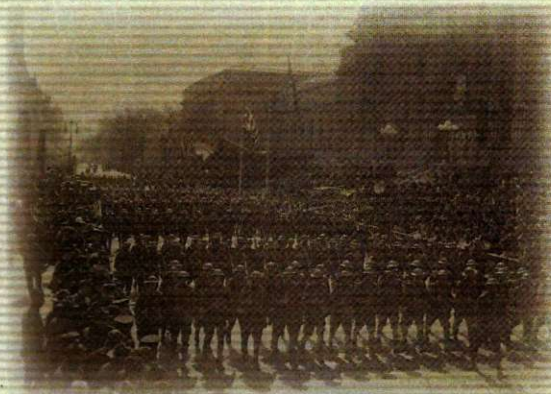

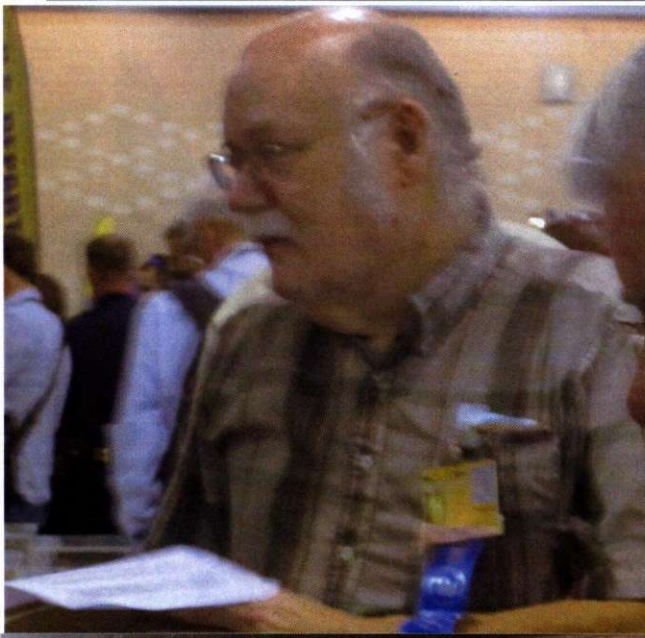

PRIVATE SOUVENIR CARDS

The SCCS was established in 1981 to pull together the many collectors of an area not previously defined – souvenir cards. Of course, our main focus is on cards produced by the Bureau of Engraving and Printing (BEP), the USPS, and security printers like the American Bank Note Co.

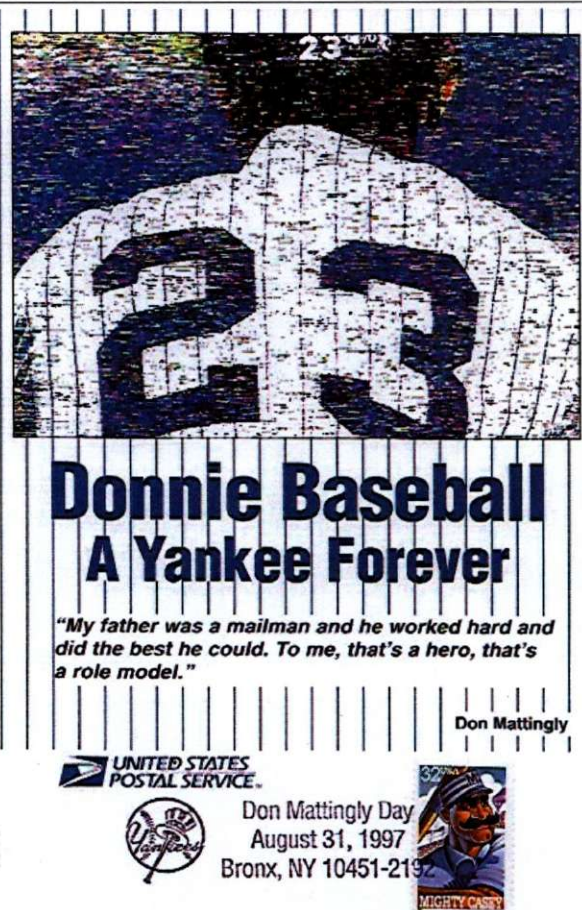
However, there is another wide area of cards that we call private cards. These have been produced by stamps shows, numismatic shows, local post offices, and even individuals. One of our members Bob Hallett even tried to catalogue all these cards! I have his printout from 1989.

My personal interest in the cards is because for 15 years, I was the coordinator for souvenirs for the FLOREX stamp show in Florida and produced a souvenir card along with an event cover. I now have several binders with over 200 private cards, and I am on the lookout for new ones.

The SCCS catalogues the national cards sold by the US Postal Service between 1960 and 1992 with the first and last Barcelona cards. However, local post masters have the ability to create souvenir cards of local interest. A 1997 card (above, right) honoring baseball hero Don Mattingly done by the USPS New York. A card (below, right) honoring the US Olympic Hockey Team in an exhibition game in DC. The collector added a second cancel with a hockey theme from Eveleth, Minnesota. These cards may also be done for second day ceremonies for prominent US postage stamps.

I recently discovered another series of cards produced by Philatelic Archives between 1972 and 1974. The Cape Hatteras Scene card (opposite, left) is number three in a series of at least eight cards. Each card has the Showgard logo so they may have been a promotion to highlight the mounted mint stamps on each card. All cards are 6 x 8 inches except for number 8 (opposite, right) that is a beautiful 8 1/2 x 11 inch card done in color lithography with wonderful Washington scenes.

Watch for these cards in dealer's bargain boxes. They often sell for \$1.00 and are a cheap and attractive way to build a colorful collection.

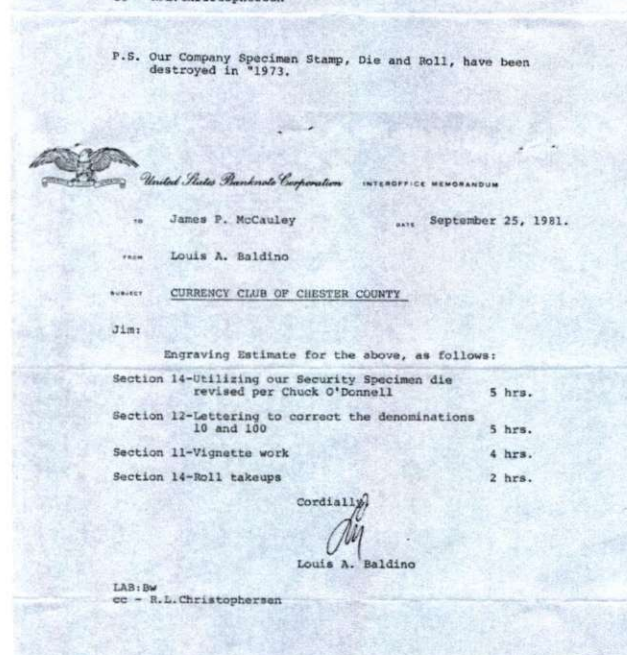
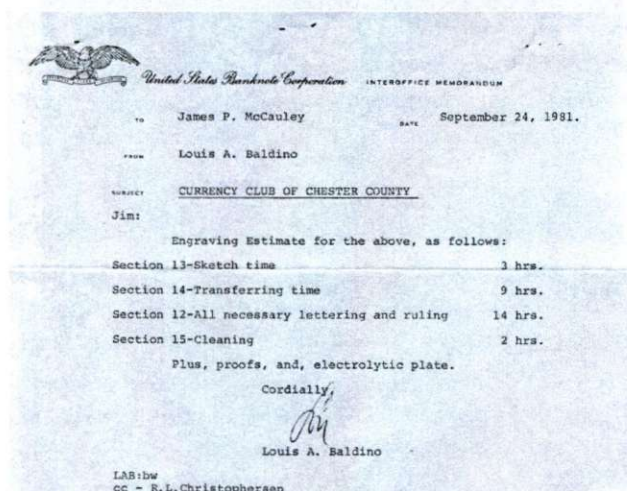
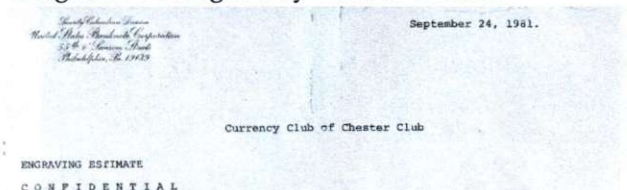

MAKING A SOUVENIR CARD

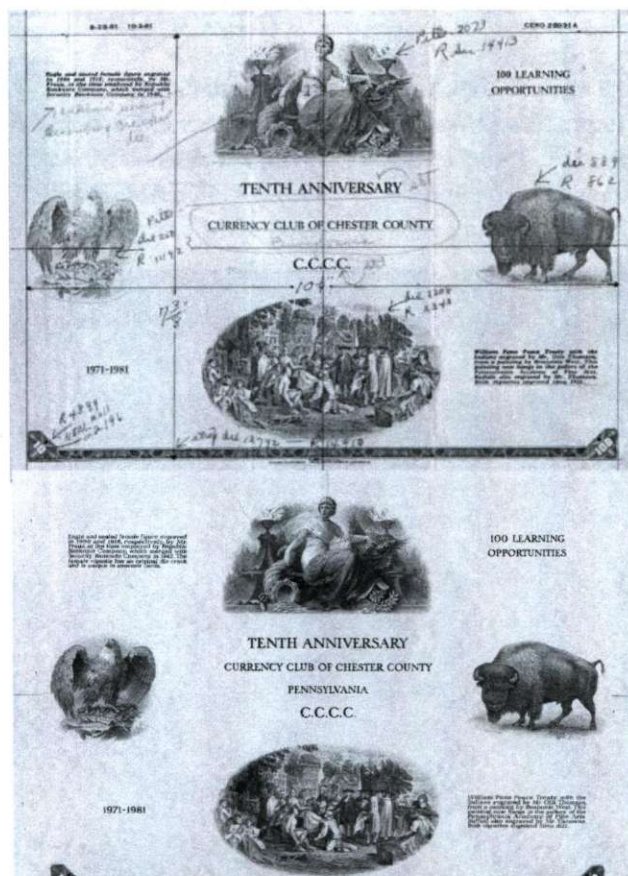
I was alerted to an eBay offer about the time the last issue went to press: production documents for the souvenir card issued for the 10th anniversary of the Chester County Currency Club (CCCC). There were seven items illustrated for only \$499.00, plus \$5.00 shipping! No, I didn't "buy in," but I did copy the images, as I thought they were of interest.



This evidence would indicate that United States Banknote Corporation was contracted to produce the card for the anniversary. What follows are notated design details.



(Above) Notations at top and left side would appear to be referring to engraver Walter Frauz, and at the bottom, to Otis Stuart Thompson, Sr. (1870-1944), whose *William Penn Peace Treaty with the Indians* was modeled from the Benjamin West painting. (This die was later used on SO-79 in 1991.) Further details were worked on (below).



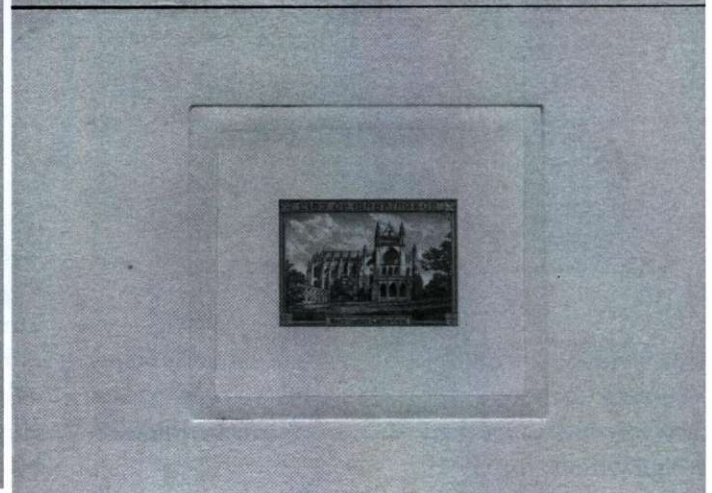
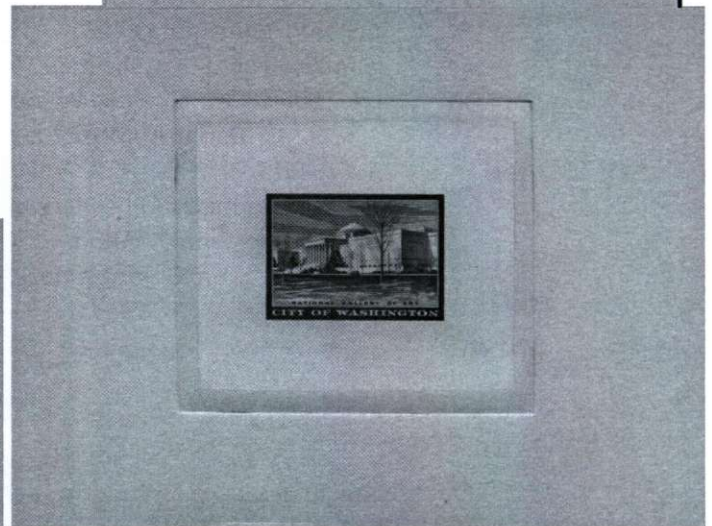
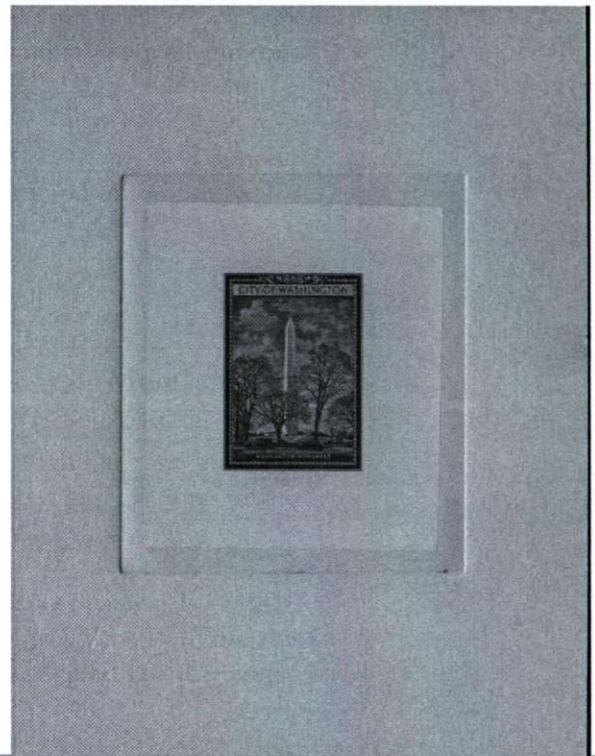
The final design (above) also was apparently looked at in a color version (opposite, below), but presumably rejected for costs considerations. To my knowledge the card exists in three single colors: SO-19, black (proof); SO-20, green; and SO-21, brown.

Something else interesting for the Journal! These are original die proofs for City of Washington scenes produced by the IPPDS&E Union in the mid-1940s. I found them for sale while surfing the web (now I can't seem to find it again). They were selling for \$3,700 -- not within my budget!

I wish these images were higher resolution, but there wasn't anything else. Don't try to enlarge them in the Journal, they will end up looking horrible. I just thought they were interesting.

[In addition to F1946A(f), three were also used on F1966A (there may be others, as yet, undiscovered) and two BEP 1969 cards: B-1 & B-3. The Washington monumet (right) seems to have been discarded! Ed.]

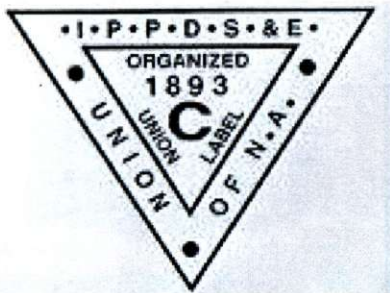

HAPPY ANNIVERSARY!

The International Plate Printers, Die Stampers, Plate Makers and Engravers Union of North America, commemorated their 125th Anniversary in June, in Ottawa, Canada.



Overtime, the Union's name has changed as other trades joined forces. This has caused some confusion in identifying cards and other memorabilia that are related to what amounts to the same organization!

The Union was founded in 1893, in Silver Spring, MD, as the National Steel & Copper Plate Printers Union of the United States of America. It was chartered by the American Federation of Labor (AFL) in 1898. A Constitution, By-Laws, and General Rules were adopted in 1900. In 1901 the Canadian locals joined the Union and it became the International Steel and Copper Plate Printers Union of North America. Amendments were made in 1902.

In 1921, the Die Stampers Union joined and now it was the International Plate Printers and Die Stampers Union of North America. In 1925, the Engravers Union joined. In 1930, the Union adopted the title: The International Plate Printers, Die Stampers & Engravers Union of North America (IPPDSEUNA). As such, their "souvenir output" since then, cards and convention booklets, are so identified. Convention cards are limited in production numbers, as they are intended for members and their families. The Union also produces cards, made available to the general public at other events like NAPEX, in much greater quantities.

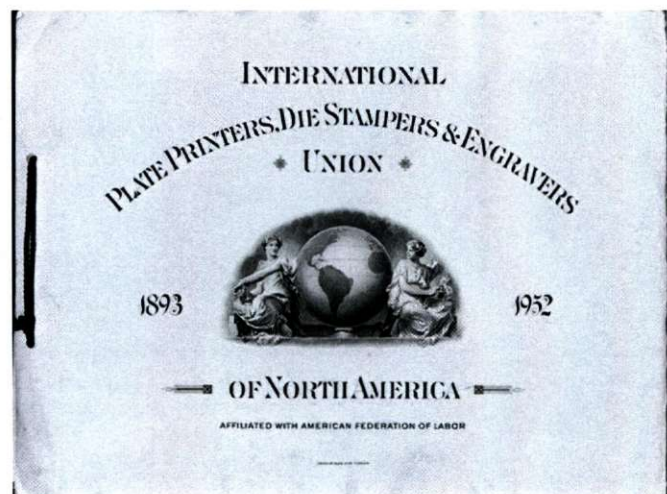
The Union held annual conventions from 1893 through 1961. Between then and 1965, two years went without a convention. Since 1965, the conventions have been held every two years. It was later decided to decrease the frequency to four years.

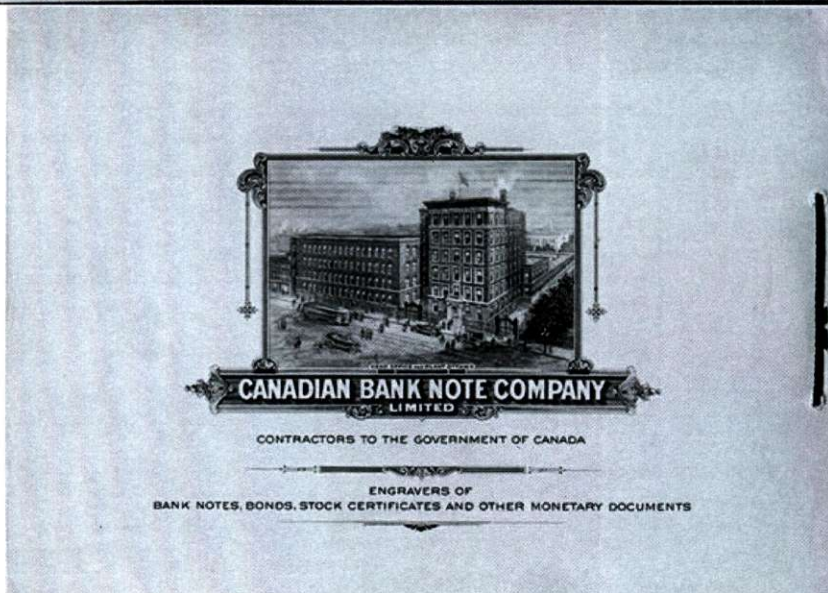
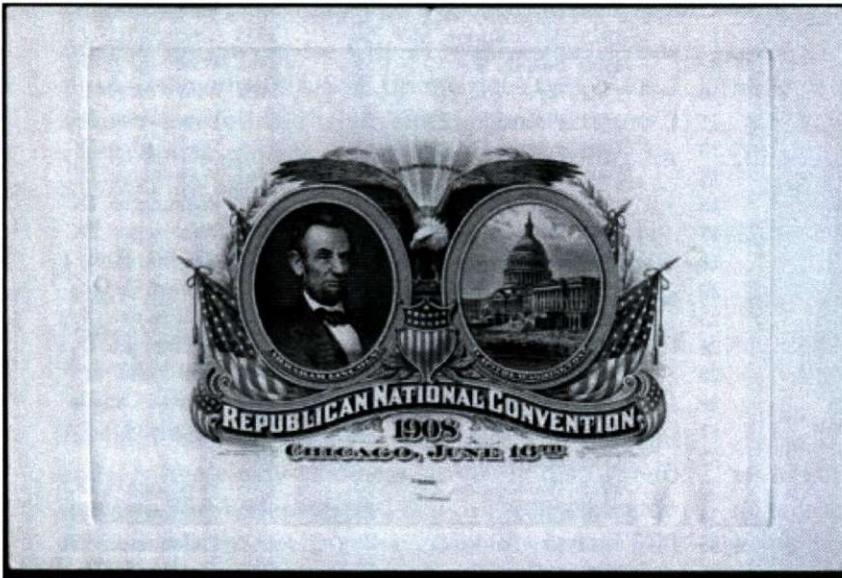
